FINANCIAL CONTRACT

Acceptance of a roster position with Azzurri Futbol Club constitutes a binding financial commitment for the full seasonal year. Parents/guardians agree to pay all Club dues and applicable team-related fees regardless of voluntary withdrawal.

Exceptions may be considered only for:

- Clinically documented season-ending injury
- Relocation outside the Club's service area
- Documented extreme financial hardship, subject to Board review

Club fees for the 2026/2027 season will be \$775.00.

Payment Options:

1. Pay the full amount of \$775.00 at registration.
2. Pay an initial payment of \$175.00 by June 15th and the remaining \$600.00 in five monthly installments of \$120.00 due July 15th through November 15th.

Payments are non-refundable except in limited circumstances as determined by the Club.

REGISTRATION & CLUB FEES

Club fees include:

- Training Fields
- Player registration and league passes
- Referees
- Field maintenance and permits
- Insurance

PLAY & GUEST PLAY

Playing time is not guaranteed and is determined at the sole discretion of the coaching staff.

Age-Based Development Standards:

- U8-U12: Development-focused with more equitable playing time
- U13+: Performance-based playing time

Guest play is permitted only with approval from the Director of Coaching and in accordance with NorCal Premier and US Club Soccer rules.

SAFE ENVIRONMENT & ABUSE PREVENTION

Azzurri Futbol Club is committed to providing a safe, positive, and respectful environment for all participants.

The Club strictly prohibits:

- Sexual misconduct or abuse
- Physical abuse
- Emotional or verbal abuse
- Bullying, harassment, or hazing

Concerns regarding misconduct should be reported to Club leadership, NorCal Premier, or the U.S. Center for SafeSport.

COMMUNICATION & CONFLICT RESOLUTION

Step 1 – Speak with the Head Coach

Step 2 – Escalate to the Director of Coaching if unresolved

Step 3 – PAD Committee Review (if applicable)

Step 4 – Club Leadership / Board Review

Parents and players agree to observe a 24-hour waiting period after games before addressing concerns with coaches.

Appropriate discussion topics include:

- Player development
- Player well-being
- Training environment
- Communication concerns

Playing time, team strategy, and other players are not appropriate topics for formal dispute or escalation.

CODE OF CONDUCT

Players agree to:

- Show respect to coaches, teammates, opponents, and officials
- Attend practices and games prepared and on time
- Demonstrate sportsmanship at all times
- Avoid drugs, alcohol, and tobacco at Club activities

Parents and spectators agree to:

- Support all players and officials positively
- Refrain from sideline coaching/addressing to coaches during games and/or practices
- Respect referees, coaches, and spectators
- Follow the Club communication policy
- Follow Sideline guidelines at games, whether home or away

Zero tolerance applies to:

- Verbal abuse or harassment
- Physical altercations
- Discrimination or bullying
- Alcohol, drugs, or tobacco use at Club events

DISCIPLINE & ENFORCEMENT

Violations of the Code of Conduct may result in:

- Verbal or written warning
- Suspension from practices or games
- Removal from team activities
- Dismissal from the Club

All disciplinary decisions are made at the discretion of Club leadership based on the severity of the incident.

PHOTOGRAPHY CONSENT

By consenting to this agreement, parents/guardians authorize the use of photographs taken during Club activities for promotional materials, the Club website, and related purposes.
